SCOPE: APPOINTMENT OF AN INDEPENDENT EXTERNAL AUDITOR TO CONDUCT AUDITS ON COMPLIANCE WITH THE CONDITIONS OF THE WATER USE LICENCE FOR THE SIX JOHANNESBURG WATER'S WASTEWATER TREATMENT WORKS.

Johannesburg Water (JW) is an entity of the City of Johannesburg (CoJ) responsible for the provision of water and sanitation. The entity has six wastewater treatment works (WwTW), namely Driefontein, Goudkoppies, Bushkoppies, Olifantvlei, Ennerdale and Northern Works. The WwTWs are located within the CoJ with the exception of Driefontein WwTW that is in Mogale City. The Department of Water and Sanitation (DWS) issued WwTW's with specific Water Use Licence (WUL).

The scope of a project:

As required by specific WUL, JW seeks to appoint an independent external auditor to conduct audits on compliance with the conditions of the WULs for the six (6) WwTWs. The external audit process will include but not limited to the following:

- Consultation with JW to plan and schedule the audits.
- Conducting external audits of all six WULs for the WwTWs.
- Compiling site-specific external audit report for the six WULs.
- PowerPoint presentation of audit findings to JW team.
- Submission of drafts and final external audit reports to JW and final report to DWS.
- All work must be completed within 14 working days from the date when the audit plan/schedule is approved and confirmed by JW.

The service provider/s must submit a proposal that at least cover the following:

- Detailed description of how the scope will be carried out (**Scope of work and plan/programme must be submitted**).
- Independent Auditor must at least have BA/BSc Honours Degree in Environmental Science/Management/Natural Sciences (**Copies of Qualifications must be submitted**).

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
