- Existing service detection for 720 square meters, including trial holes within 20 meters intervals.
- Excavate up to 1.5 meters and 2 meters depth, for pipeline laying, for 240 meters
- Supply and lay 240 meters of DN350 Mpvc pipeline, with 6 x 45 degrees bends,
 1 tee off (350 x 100), Water valve and 1 fire hydrant.
- Tie-in and commission the new pipeline.
- Backfill, reinstate and make good.

The prospective tenderers shall take into consideration all safety precaution requirement in compliance with the Occupational Health and Safety Act, 85 of 1993 with associated Regulations and environmental requirements as per National Environmental Management Act 107 of 1998.
