1.1.1. Overview of the Works

The scope of work to be performed under this contract is electrical works. The works shall be executed on existing infrastructure and certain sections of the existing installation may be live during installation.

The prospective tenderers shall take into consideration all safety precaution requirement in compliance with the Occupational Health and Safety Act, 85 of 1993 together with Regulations promulgated thereunder. The work is to be carried out at Driefontein Wastewater Treatment Works.

1.1.2. Electrical Works

- Locate cable fault(s) on the cable portions of the Eskom feeder 1.
- Inspect the overhead line portions of Eskom feeder 1 and Eskom feeder 2 and provide a signed written condition assessment report.
- Locate cable fault(s) on the cable between main intake switchgear and Lucy switchgear (Biogas Plant Switch).
- Repair identified cable faults on the Eskom feeder 1 and Biogas Plant Switch feeder.
- Repair faults on the overhead line portions of Eskom feeder 1 and 2, if need be.
- Test and commission all the repaired MV cables.
- Supply, install and commission MV CT's on Eskom feeder 1 and Biogas Plant Switch panels on the main MV switchgear.
- Replace the batteries of the BTU for main MV switchgear (supply, install and commission).
- Replace the batteries of the Bioreactor 1 MV switchgear (supply, install and commission).
- Replace stolen earth and bonding cables in the main MV switchgear room, Bio 1 MV switchgear room and Bio transformer room.
- Bond all metal structures in and around the main MV switchgear room, Bio 1 MV switchgear room and Bio 1 transformer room.
- Repair cable trench cover support in the main MV switchgear room.
- Test the earth resistance of earth electrode for the incomer RMU, MV transformer rooms, MV switchgear rooms and miniature substations.

- Test bonding resistances between main earth bar and equipment and extraneous conductive parts at main MV switchgear room, Bio 1 MV switchgear room and Bio 1 transformer room.
- Inspect, test and certify lightning protection installation at main MV switchgear room. Certificate must be issued by ELPA accredited contractor. Bond LPS to main earth system
- Sample transformer oil in all the transformers.
- Test oil samples at SANAS accredited laboratory. Oil test lab report and results technical analysis report must be issued to JW.
- Service transformers as per oil sample results including repair of oil leaks.
- Pressure-test all serviced transformers as per SANS 780 before re-commissioning.

1.1.2.1. **Scope of Contract**

The scope of work under this project will be on a live, operational site and the prospective tenderers must therefore take cognizance of this fact when compiling their respective occupational health and safety plans and shall accommodate appropriate safe working procedures. It is considered essential that the quality of the final effluent discharged by the works shall take precedence over the contractor's rate of progress when performing the work and the contractor shall therefore make sufficient allowance in the proposed construction programme. The scope of work to be performed under this contract shall consist of the electrical works as provided above. The contractor is expected to provide security and insurance for their equipment installed under this contract until the equipment are fully and formally handed over to Johannesburg Water.

- Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
 - This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

Bid rigging is, therefore, an agreement between competitors not to compete.
