#### 1. PURPOSE OF THE REQUEST FOR INFORMATION

#### 2. BACKGROUND

Johannesburg Water operates several data servers and storage devices to host its systems and applications. There are in the region of 20 physical data servers, 80 virtual servers, 3 storage devices and 2 backup devices in the IT data centre at Head Office and at the Disaster Recovery (DR) site.

IT department last bought the servers in 2014 and now they have reached end of life as per the OEM speciation's. Johannesburg Water seeks to replace these servers with a faster, newer technology that can provide high availability to the applications.
