## **ANNEXURE**

- Replace "Denso" with "Denso or equivalent" in the following sections in the tender document:
  - Bill of Quantities, Section 2.1 : Bulk Water Pipeline (Crosby), Bill No. 7, Item No 143
  - Bill of Quantities, Section 2.2 : Bulk Water Pipeline (Hursthill), Bill No. 7, Item No 115
  - Particular Specifications, Section C3.3.2.4.10.18.2
  - Particular Specifications, Section C3.3.2.10.4.3.11.3A; and elsewhere throughout the document.
- Clause C3.2.2.9.2.2.1, Paragraph C; PSL 3.4.3 Pipes of nominal bore over 150mm is to be replaced with the following:

"Steel pipes and fittings shall be manufactured in accordance with API 5L X42 with a wall thickness of 12mm; 10mm, 8mm or 6mm, depending on the section of pipe in question. External lining to be Polyisobutene Visco Elastic (STOPAQ or similar approved, or other as specified by the Employer) and internal lining to be Solvent Free Epoxy with a target thickness of 600 microns. Pipe lengths to be 12.192 m.

Straight joints and bends to be fillet welded on site. The pipe manufacturer shall submit to the Engineer the steel maker's certificates covering all steel used. These certificates shall indicate the process of manufacture, the chemical analysis and the physical properties of the steel except that, at the option of the pipe manufacturer, the physical properties of the steel may be determined from specimens taken from finished pipe."

# 2. Internal Coating (Lining) for all steel pipes ≥600mm

Corrosion Protection internal coating (lining) must be Potable Water certified Solvent Free Epoxy (SFE) with a min. DFT 600µm.

## 3. External Coating for all steel pipes >150mm

Corrosion Protection Coating must be Polyisobutine Visco-Elastic (STOPAQ or similar approved, or as specified by the Employer) with a glass reinforced epoxy / elastomeric (GRE) outer mechanical.

## 4. Steel Pipe Bends and Specials

Corrosion Protection internal coating (lining) must be Potable Water certified Solvent Free Epoxy (SFE) with a min. DFT 600µm.

Polyisobutine Visco-Elastic corrosion protection layer (STOPAQ or similar approved, or as specified by the Employer) on the external steel substrate with HDPE / PVC tape outer mechanical on the straight pipe field joint repairs and PVC tape outer mechanical on the pipe bends and specials.

## 5. Minor / Major Repairs and Field Joint Repairs

The field joint repairs, on-site defect repairs and hand wrapping material used must be fully compatible with the mainline corrosion protection coating to achieve a
