1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

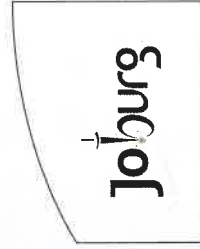

INSTRUCTIONS TO ALL DRIVERS AND LINE MANAGERS USING JW VEHICLES

(NB: departmental internal instructions to be always observed)

1. Each vehicle is allocated with its logbook and drivers are responsible for completing logbooks daily and all trips must be recorded (opening and closing kilometres).
2. It is the responsibility of line managers to check and sign logbooks on a weekly basis and any discrepancies must be raised with the driver. Transport Officers must check and sign logbooks at the end of each month.
3. No smoking or use of intoxicating substances is allowed inside JW vehicles.
4. Drivers are responsible for the cleanliness and good condition of the vehicle.
5. Drivers are to ensure the vehicle is fitted with a spare wheel and its tools, i.e., jack, wheel spanner, emergency triangle.
6. Drivers are responsible for removing and the safe keeping of tools when vehicles are sent to workshops for repairs; workshops will not be held responsible for the loss of tools.
7. Drivers must ensure that the correct speedometer reading is recorded into each book.
8. All dents (whether small or big) and defects on a vehicle must be reported to the Transport Officer by the driver.
9. All vehicle keys must be handed over to the line manager upon return from sites for safe keeping and no driver is allowed to leave work with vehicle keys.
10. In the event of an accident, if possible, the driver must immediately inform the line manager who will contact the Transport Officer.
11. Towing of vehicles will only be authorized by Transport Officers.
12. All vehicles parked at residences of drivers must be accompanied by a valid authorisation signed by the departmental head or designated official.
13. No unauthorised passengers are allowed in JW vehicles.
14. Wherever possible, a driver must seek assistance when reversing a JW vehicle. Where no guide is available, the driver must exercise extreme caution and first ensure that it is clear and safe before reversing a vehicle.
