Unified Platform: Integrate SAP Ariba with the existing SAP ECC 6.0 system to provide a unified digital platform for procurement, supplier management, and contract lifecycle management.

Enhanced Collaboration: Enable seamless interaction between internal systems and external partners for supplier engagement, contract execution, and payment processes.

Real-Time Data Exchange: Ensure consistent, real-time data flow between systems to improve decision-making and reduce process inefficiencies.
