#### **1 SCOPE OF WORK**

Proposals for the following service are requested:

Section 7.2.1 of the Recruitment Policy indicates that If no suitable candidate is found internally, the position must be advertised externally (the position may still be advertised externally if internal appointment will not further EE objectives from grade 22 and above). Depending on the position, the position might be advertised simultaneously (internal and external) however internal applications will be considered first. In the event there is no suitable candidate both internal and external, the recruitment agencies shall be utilized to source the candidate. Section 7.2.4 indicates that the selection of a recruitment agency will be made the responsibility of the human resources person from the list of accredited BBBEE recruitment agencies or appointed agencies.

The agencies will also be responsible for sourcing temporary employees in the following event.

- There is a vacant position, and the recruitment process takes longer than anticipated.
- There is a temporary Project.
- Incumbent on Maternity leave; and
- Incumbent on extended absenteeism
