Site: Johannesburg Water Northern Wastewater Treatment Works

Notes

The three flow meters must be installed on three different pipelines as indicated below (Installation 1 and Installation 2). The following notes apply for the installations:

- The pipes are housed in a meter chamber.
- Enclosure/housing for flow converters and data loggers will be available next to the meter chamber with the power supply terminated in the enclosure.
- The installation (workmanship) and supplied flow meter must carry a minimum of a twelve (12) months warranty.
- Installation documentation, photos, site setup parameters, operator and maintenance manuals to be provided after completion.
- Flow verification of installed meters to be carried out after installation and verification certificate must be issued.
- The GSM data logger, to be installed with the flow meter will be free issued.

Installation 1

- Two ultrasonic flow meters to be installed on two different parallel pipelines housed in the same chamber.
- The two pipelines of approximately 250mm, Class 6 U-PVC. Pipe wall thickness to be accurately determined during the installation process.

Installation 2

- The pipeline is approximately 600mm carbon steel pipe with lining type and lining condition unknown. Pipe wall thickness to be accurately determined during the installation process.
- The protective outer coating (bitumen) on the pipe will need to be removed during installation and suitably repaired afterwards where the instrument is be installed.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
