## SCOPE OF WORK

### 14. Scope of Work

#### 14.1 BACKGROUND AND WHY THE NEED TO SOURCE THE GOODS OR SERVICES

The Operations Department carries Disconnections and Reconnections of Water Supply within the City of Johannesburg due to credit control action on accounts in arrears. These services rendered under this contract are vital for revenue collection on customer accounts that fall into arrears in order to enhance the City of Johannesburg financial sustainability.

#### 14.2 CONTRACT DESCRIPTION

The contract entails the Disconnections and Reconnections of Water Supply within the City of Johannesburg due to credit control action on accounts in arrears on an as and when required basis in accordance with the specifications as outlined in this document for a period of thirty-six (36) months on an “as and when” required basis.

#### 14.3 SCOPE OF WORK

The service provider will be required to supply, provide labour, transport and certain materials/equipment, to perform water cut offs / disconnections and reconnections on mains and prepaid meter supply on an “as and when” required basis within the City of Johannesburg.

#### 14.4 EXTENT OF CONTRACT

The contract entails level three (3) cut offs / disconnections and reconnections of water supply within the City of Johannesburg due to credit control actions on an “as and when” required basis for a period of thirty- six (36) months.

##### 14.5.2 AVERAGE STATISTICS

The average statistics of the disconnections of water meters on monthly basis is approximately to +/- 300 meters with the current five JW teams.

#### 14.6 JOHANNESBURG WATER (SOC) LTD RESPONSIBILITIES

JW's responsibilities on the contract are as follows.

- 14.6.1 To provide the contractor; as far as practically possible on a daily basis a schedule of stand numbers, meter numbers, street addresses and suburbs of consumers identified for water disconnections and reconnections as applicable. The contractor will ensure knowledge and access to Geographical Information System (GIS) that uses the property stand number as a location reference

## **SCOPE OF WORK**

14.6.2 To provide the Contractor as far as practically possible before 09:00 on a daily basis, such schedules as contemplated in 5.6.1 above.

### **14.7 CONTRACTORS RESPONSIBILITIES**

The following are the responsibilities of the contractor.

14.7.1 The contractor will complete a site inspection form with the meter serial number/s, readings, job done and description of the property thereof.

14.7.2 The contractor shall supply locking devices to secure the stopcock or as deemed appropriate.

14.7.3 An electronic file containing the site inspection information must be submitted to JW within 72 hours subsequent to site inspections.

14.7.4 The Contractor shall procure materials, equipment and consumables to execute disconnection of water supply services. The JW representative (Officer Materials-Operations Technical Services) must approve such materials, equipment and consumables upfront.

#### **14.7.5 Water disconnection on the main water supply**

In the event of water cut offs on the main, the contractor shall be responsible for acquiring the necessary wayleave approval from JRA and thereafter making provision for the necessary plant and equipment in order to expose and backfill the road reserve and/or affected area.

The contractor shall also liaise with the relevant depot personnel in order to apply for the isolation and reconnection of the water supply to the affected area.

Having affected the successful disconnections of the supply, the contractor shall backfill, compact and reinstate the area to its original state whether it be tarred, paved or grassed.

The contractor shall also take necessary safety precautions whilst performing all the above duties.

#### **14.7.6 Water Disconnection on prepaid meter**

In the event of water cut offs on prepaid meter, (i.e. at the stop cock before the pre-paid meter) the contractor is expected to fit a suitable locking device on the said stop cock (contractor to supply the suitable locking device). This might entail exposing the stop cock in order to fit the device.

The contractor shall be held accountable for locking devices lost or damaged and therefore needs to keep accurate record of all devices issued to them by JW and also record of site distribution.

#### **14.7.7 Water Reconnections on main supply and prepaid meters**

14.7.7.1 In the event of a reconnection on the main, having affected the successful reconnections of the supply, the contractor shall backfill, compact and reinstate the area to its original state whether it be tarred, paved or grassed.

14.7.7.2 In the event of a reconnection on prepaid meter, the locking device is to be removed and kept at a safe place for further use again.

14.7.8 Attend to complaints and/or investigations grouped in one area or attend to a single complaint and/or investigation in any area as requested by Johannesburg Water.

14.7.9 Ensure that the best interests of JW and the City of Johannesburg are served as a result of the execution of this contract. To ensure that staff executing the works on behalf of the contractor act in a professional, responsible manner and behave amicably at all times.

## SCOPE OF WORK

14.7.10 To communicate and liaise with JW official representatives (Foreman Disconnections) regarding the disputes on site related to disconnections with the objectives and intentions of resolving the problem thereof.

14.7.11 To ensure, that when legal disputes arise between JW and consumers as a result of execution of this contract, the Contractor and/or employees of the Contractor be available to attend any proceedings as required.

Keep accurate records of work undertaken and produce such reports or statistics as may be required by JW both in hard and soft copies.

The Contractor shall set out the works and do any resetting out of which may be required and shall amend at his own costs any errors arising, in the opinion of JW, from inaccurate setting out and shall be responsible for the consequences of any error.

Maintain a permanent based office operations during normal working hours, suitably staffed to the satisfaction of JW, such that messages, instructions, etc. may be relayed through it to the field staff.

14.7.12 To communicate any information, findings, or to part with any knowledge gained during execution of this contract, that may in future be beneficial to JW. The tenderer shall divulge to JW, all information obtained in the process of execution of the contract and shall make same available to JW immediately upon ascertaining such information. Failure to abide with this requirement shall be considered as a breach of contract.

14.7.13 The contractor may be required to provide security to areas deemed not safe.

## 14.8 INSTRUCTION TO BE ISSUED TO CONTRACTOR FOR THE DISCONTINUATION OF WATER SERVICE

14.8.1 Discontinuation (cut-off) instructions and default

14.8.1.1 All instructions issued to the Contractor must be carried out on the same day. Should this not be possible, the Contractor shall report this to JW's representative indicating the reasons, therefore. Alternative cut-off dates will be arranged at the discretion of JW.

14.8.1.2 Before attempting to interrupt the water supply of any consumer, the Contractor shall verify the physical address, the name of the owner/occupant where applicable, and the meter numbers as indicated on JW Schedule and Termination of Supply Notice. The Contractor should under no circumstance terminate the water supply if the actual meter number does not correspond with that on the JW Schedule and Termination of Supply Notice.

14.8.1.3 *The Contractors must familiarise themselves with the JRA SOP (latest applicable) requirements in terms of applying for the wayleaves prior to any disconnection of water service.*

## 14.9 COMPETENT PERSON

For all water disconnections and/or reconnections as required, the contractor shall only utilise tradesmen suitably qualified in this field and suitably trained in this type of work. All water disconnections and/or reconnections shall be carried out under the supervision of a qualified plumber. All artisans working on the water network shall use only approved plumbing tools.

## 14.10 STANDARD OF SERVICE

The Contractor must, during the course of the contract period ensure that the best interests of JW are served at all times.

Recommendations and advice must be based on impartial observations, reasonable opinions and pertinent facts.



## SCOPE OF WORK

The Contractor shall be responsible for the actions of any sub-contractors employed by him and shall ensure their professional conduct at all times.

All work carried out under this contract shall be of a standard acceptable to JW. No payment will be made for work not complying with JW's required standard of work.

### 14.11 WORKING PLACES

JW will require the contractor to run a suitable furnished office with tables, chairs, cabinets, desktops / laptops, printer and access to internet accompanied with the necessary software packages. JW will inspect the site at any given time to ensure compliance. The different areas per region are as follows:

### 14.12 SCHEDULE MATERIAL

The Contractor will be required to keep accurate records detailing the circumstances surrounding the replacement or utilisation of, but not limited to, locking devices, orifice plates and tools.

Where damaged water supply equipment is replaced, the damaged unit/s must be returned to JW bearing an identification tag reflecting stand number/Street address and house/flat/business number or JW account number.

The Contractor will be responsible for supplying stock for all disconnection devices to be utilized on this project. Monthly reconciliation figures must be included in the Monthly Report outlining stock used and stock returned.

The contractor must ensure proper stock control. Unused new meters must be returned to stock with a tag indicating reasons on non-usage. Serviceable used meters and accessories must be inspected, cleaned and calibrated by a SANAS accredited body.

Monthly Report to include the following:

- Reconciliation of meters and material used or returned with job requests
- Job cards summary and quality inspection details
- Record of disconnections and reconnections
- Meter data indicating (serial no., make, type, size and reading)
- Wayleave and reinstatements record
- Assessment summary of error codes returned for the month
- A detailed list of personnel appointed for this contract
- Quantities of materials for the month
- Report on Rand Water joint meter reading including challenges

### 14.13 ACCESS TO PREMISES AND DELIVERY OF DOCUMENTATION

JW will endeavour to furnish the Contractor with as much accurate information as possible on the type of premises where the disconnection or reconnections action is to be carried out.

Where access to a consumer's premises is not readily available, the Contractor shall make the necessary arrangements to gain access to the premises at a time suitable to the consumer, albeit outside of normal working

hours.

Where access as contemplated above cannot be gained, the Contractor shall report such situation back to JW, and advise JW of what alternative arrangements, if any have been made.

### 14.14 IDENTIFICATION TAGS

Two identification tags are to be affixed to the supply equipment of the service to be disconnected; the tags are described as follows:

#### (a) Permanent Identification Tag

This identification tag is to be permanently placed on the service equipment found at the supply end of the service to be disconnected which must be clearly and indelibly marked with specifying the following information:

- (i) Account number
- (ii) Stand number and township
- (iii) Meter number/s
- (iv) Contractor identification number

#### (b) Status identification Tag

The status identification tag is to be affixed to the equipment found at the supply end of the service to be disconnected to indicate that the service has been terminated and must be removed should the service be legally reconnected.

The following information must be clearly and indelibly marked on the status information tag:

- (i) Level of disconnection
- (ii) Account number
- (iii) Time and date of disconnection
- (iv) Work instruction number
- (v) Contractor identification number
- (vi) Stand and township number

### 14.15 DISCONNECTION AND RECONNECTION WORK ON WATER INFRASTRUCTURE

Definitions for the levels of restrictions and disconnections are as follows:

#### Level 3: **DISCONNECTION AT THE MAIN**

- (a) A level 3 disconnection must be performed according to the instruction by removing the complete installation from the meter outlet connection to the main.

**Note:** Before departing from the site, the Contractor must ensure that there are no water leaks emanating from the infrastructure. Should there be signs of water leakage or stopcock bypass, the Contractor must report the same before departure to a designated Johannesburg Water personnel.

**Note:** Contractors may be required to carry out water disconnections and/or reconnections outside of normal working hours. The Tenderers attention is drawn to Clause below.

It remains the Contractors responsibility to ensure that the most effective credit control action is affected. Should service connection configurations be encountered other than those described in this document, such occurrence must be reported to JW representative for clarity.

The Contractor must indicate as a separate charge, his price, for reconnecting any water supply which was disconnected or dismantled by JW, or others.

## SCOPE OF WORK

### **14.16 INTEGRITY AND CARE OF JOHANNESBURG WATER (PTY) LTD PROPERTY**

The Contractor shall at all-time respect and take care of JW property.

The Contractor shall not, modify, remove or damage in any way whatsoever JW owned property without the express written consent of the JW representative.

Any Contractor, Sub-Contractor or agent of the Contractor found tampering with, damaging, or neglecting to take care of any JW infrastructure will be regarded as a breach of Contract. JW reserves its rights in this regard to take such appropriate actions against the Contractor.

All water meter enclosures shall be closed after completion of the instructed task.

When working on the water reticulation system for purposes of discontinuing/disconnecting or reconnecting a supply, the Contractor shall ensure that there are no water leaks, and that all connections are made in accordance with best plumbing practices.

### **14.17 CITY OF JOHANNESBURG CREDIT CONTROL POLICY**

The successful tenderer will be required to attend an induction meeting on City of Johannesburg Credit Control Policy. The induction course will be conducted by JW Representative and will bring to the attention of the Contractor pertinent aspects of the current City of Johannesburg policy on credit control.

No work will be permitted until such time as the Contractor has attended such induction meeting.

### **14.18 REPORTING TO JOHANNESBURG WATER (SCO) LIMITED**

Notwithstanding any other requirements pertaining to report back to JW by the Contractor, the Contractor shall, report in writing to JW any such cases where there may be any installation where leaks or damage to water infrastructure is prevalent. The Contractor shall on a daily basis after having completed such water disconnections or reconnection as required, telefax or hand such details to the JW representative.

Any cases of illegal service connections or fraudulent actions regarding the use of water by a consumer must be brought immediately to the attention of JW.

### **14.19 CONTRACTOR AND STAFF PROTECTION**

The Contractor shall make his own arrangements with regard to the security and safety of his staff, equipment and resources whilst executing work in all areas, including problematic or "unrest" areas.

Any cost associated with this action shall be included in the tendered price and reflected in the Form of Tender. JW will advise the Contractor of the areas regarded as problematic with regard to execution of this contract.

Before undertaking work requiring the presence of security personnel, the Contractor shall advise and obtain approval from JW whose approval will not be unreasonably withheld.

JW will assist with any credit control actions that are to be carried out in the so-called problematic areas.

No payment for such protection as envisaged by the content of this clause shall be made, unless such written approval has been obtained prior to carrying out the work.

### **14.20 WORK INSTRUCTION AND WORK CARRIED OUT, OUTSIDE OF NORMAL WORKING HOURS**

It is JW's intention to compensate the Contractor for execution of work outside of normal working hours, when so instructed by JW.

Cut off time/Disconnections should be executed during working hours as between 07:00 and 16:00 Monday to Friday. Reconnections can be done during normal working hours 07:00 – 16:00 and any time after hours from 16:00 to 21:00 where necessary.

## SCOPE OF WORK

Overtime should only be carried out if necessary to do so instructed by JW.

### 14.21 PAYMENT OF DISCONNECTIONS/RESTRICTIONS

Jobs reported as disconnected/restricted will be paid as follows: -

- 14.21.1 The full rate of disconnection/restriction will be paid where there is a request for reconnection that is subsequent to compulsory payment arrangement or proof of payments.

### 14.22 PAYMENT OF INVOICES

- 14.22.1 Payment will be affected from 30 (thirty) days of the date of statement receipt by JW on the monthly invoice/s received from Contractors on conditions that:

- (a) The services received were acceptable to JW
- (b) The price reflected on the invoice/s corresponds with the tendered price and category
- (c) JW agrees with the totals for the work provided and received from the Contractor/s
- (d) The particulars of the Contractor/s on the invoice/s correspond with the particulars of the Contractor/s contained in the Agreement.

- 14.22.2 There shall be no payment for certain logistics codes where the required work was not conducted by the Contractor.

- 14.22.3 Disputed Invoices

- (a) If any item or part of an item on an invoice/s submitted by the Contractor/s is disputed by JW, JW shall give prompt notice with reasons and shall only make payment when the invoice/s is/are rectified accordingly.

### 14.23 PENALTIES

- 14.23.1 JW reserves the right to audit the contractor/s work. A penalty will apply on the monthly invoice/s submitted by the Contractor in the following cases and based on the item:

- (a) Contractor indicates reconnections/disconnection executed, but audit proves work incomplete on the site.
- (b) Incorrect use of logistics codes, where logistic codes used does not correlate with reason why instruction could not be executed.
- (c) Penalty will apply as follows:
  - 1.5 X Rate shall be applicable between turnaround time of 48 hours and 72 hours
  - 2.0 X Rate shall be applicable if the turnaround time is above 72 hours

Tenderers should take note of the penalty and default conditions contained in this document and should ensure that they fully understand the implications thereof before submitting tenders for consideration.

### 14.24 LEGISLATIVE AMMENDMENTS

The City of Johannesburg may revise its Municipal by-laws from time to time.

Where such changes effect the content and operation of this contract, such amendments will be communicated to the contractor, who in turn, will be required to carry out the work in accordance with any instruction issued by JW, resulting from the change in City of Johannesburg Metropolitan Municipality by-law/s.

In such instances where changes in National or Provincial Legislation require that the City of Johannesburg and/or service provider Utility (JW) alter the modus-operandi in respect of water service delivery to consumers, or where any such Legislation affects JW's operation in respect of "Credit Control" is concerned, such amendments shall be conveyed to the Contractor.

JW may at its discretion issue written variation instructions in this regard, having first negotiated same with the tenderer, alternatively, where no agreement is reached or the variation will be of such a nature that the intention and scope of this contract is unrealistically and/or unreasonably altered, JW reserves the right to terminate this contract and call for new tenders if it so wishes.

### **SCOPE OF WORK**

The tenderer accepts by submission of his/her tender, that in respect of the aforementioned changes, should they occur, the tendered price per unit will remain unchanged from that which was originally tendered, but a variation in working or operating procedure is acceptable.

#### **14.25 DURATION OF THE CONTRACT**

The contract is for a period of thirty-six (36) months on an “as and when” required basis.

## SPECIAL CONDITIONS

### 20 Special Conditions:

#### GENERAL

- NB** The attention of the tenderer is drawn to the fact that General Conditions of Contract shall apply, where applicable, to this contract.

#### DEFINITIONS:

- 1.1 That "Johannesburg Water (Soc) Ltd" shall herein after being referred to as "JW".
- 1.2 The "Managing Director" shall mean the Managing Director: Johannesburg Water (Soc) Ltd or his authorised representative.
- 1.3 "Vat" shall mean Value Added Tax in terms of the Value Added Tax Act 89 of 1991 as amended.

#### PRICE:

- 2.1 All prices shall exclude Value Added Tax (VAT) at the standard rate as gazetted from time to time by the Minister of Finance in terms of the Value Added Tax Act 89 of 1991 as amended.
- 2.2 All price(s) tendered shall include the cost of all insurances supply, transport, tools, labour, equipment, materials, etc. and be the net price after all discounts and settlement discount have been deducted. The net price/s shall be without any extra or additional charges to JW whatsoever.
- 2.3 A firm price is required.

#### SURETY BOND:

- 3.1 No surety bond shall be required in terms of this contract.

#### COMPLIANCE WITH LEGISLATION AND SPECIFICATION:

- 4.1 The contractor shall comply with all Municipal By-laws, and any other Laws, Regulations or Ordinances and shall give all notices and pay all fees required by the provisions of such By-laws and Regulations specified therein.
- 4.2 The contractor shall comply with all the requirements prescribed in the specification.

#### SAFETY:

- 5.1 Without derogation from the generality of Clause 4.1, or from any other provision of this contract, the Contractor shall at all times during the contract, comply in all respects with the safety and other requirements of the Occupational Health and Safety Act of 1993 and the regulations applicable hereunder.

#### EMPLOYMENT OF LABOUR:

- 6.1 The contractor must ensure that all relevant legislation is complied with in the employment of labour.

## **REMEDIES, BREACH, WHOLE AGREEMENT, WAIVER, VARIATION AND INDULGENCES:**

- 8.1 If the contractor or any person employed or associated with him or in the case of a Company, a Director or shareholder or person also associated with such Company, either directly or indirectly gives or offers to give any gratuity, reward or commission or other bribe to any person in the employ of JW this contract shall be avoidable at the instance of JW.

- 8.2 If the contractor has not complied with the Managing Director's requirements or if he is in breach of any of the Conditions of this contract and:

- 8.2.1 Fails to remedy such breach within 14 (fourteen) days of receipt of written notice requiring it to do so (or if not reasonably possible to remedy the breach within 14 (fourteen) days), within such further period as may be reasonable in the circumstances, provided that the Contractor furnishes evidence within the period of 14 (fourteen) days reasonably satisfactory to JW, that it has taken whatever steps are available to it to commence remedying the breach), then the JW shall be entitled, without notice and in addition to any other remedy available to it at law or under this agreement, including obtaining an interdict, to cancel this agreement or to claim specific performance of any obligation whether or not the due date for performance has arrived, in either event without prejudice to JW's right to claim damages.

- 8.2.2 Should JW elect to cancel the contract then and in such instance a certificate presented by the Managing Director of JW shall constitute proof of the contractor's indebtedness to JW.

- 8.3 This agreement constitutes the entire agreement between the parties relating to the matter hereof.

Any such extension, waiver or relaxation or suspension, which is so given or made, shall be strictly construed as relating to the matter in respect whereof it was made or given.

## **DISPUTES:**

- 9.1 In the event of any dispute arising between JW and the contractor in connection with or arising out of the contract, it shall be referred to the Managing Director of JW who shall state his decision in writing and give

notice of the same to the Contractor within 28 days of the dispute having been submitted to the Managing Director of JW. Such decision shall be binding upon the contractor subject to clause 9.2

9.2 Should the contractor be dissatisfied with the decision of the Managing Director he/she may, within 28 days after receiving notice of such decision, require that the issue or issues be referred to a single arbitrator to be agreed upon between the parties or, failing agreement, to be nominated by the Chairman of the Association of Arbitrators and any such reference shall be deemed to be submission to the arbitration of a single arbitrator in terms of the Arbitration Act, 1965. The award of the arbitrator shall be final and binding on both parties.

9.3 Not later than one week after receipt of notice calling for arbitration, JW may give notice to the contractor that the dispute or disputes be settled by Court of Law having jurisdiction.

### **SCOPE OF CONTRACT**

10.1 The service provider will be required to supply, provide labour, transport and certain materials/equipment, on an "as and when" required basis for water cut offs on main and prepaid meters and reconnections of water supplies within the City of Johannesburg.

### **DURATION:**

11.1 The term of the contract shall be for a period of thirty-six (36) months.

### **QUANTITIES**

12.1 This is an as and when required contract and no exact quantities or makes/models have been indicated due to the nature of the contract. The contractor shall be bound to perform cut offs and reconnections of water supply for a period of thirty-six (36) months.

### **OPERATING TIME:**

13.1 Operating times of the JW stores or depots are during normal working hours, Monday to Friday 07:00 hours to 16:00 hours and excludes weekends and public holidays, however the service provider will not be allowed to close during contractor's annual break.

### **REQUIREMENTS:**

14.1 The contractor is required to execute disconnections and reconnections of water supply as per the responsibilities stipulated in the Technical Specifications of the tender document.

14.2 The contractor is required to increase the availability number of supervisor/foreman if the ratio is bigger than of (1:5). i.e. 1 supervisor/foreman with 5 plumbers per team.

### **TENDER VALIDITY:**

15.1 The Tender shall be valid for a period of 90 days from the date of closing of Tenders.

### **ADJUDICATION OF TENDERS:**

16.1 The highest, lowest or any tender will not necessarily be accepted by JW. JW reserves the right to adjudicate the Tender to JW's best interest and it is not necessarily intended to award the Contract to only one Contractor.

### **ACCEPTANCE OF TENDER:**

17.1 A valid and binding contract shall be concluded at the time when the Service Provider receives an official appointment letter and sign letter of acceptance at the offices of JW after the Service Provider where he/she will enter into a contract with JW with the term and conditions packaged in this document.

**COMPLETENESS:**

- 18.1 Failure by the tenderer to complete in full the attached Form of Tender will render the tender liable to rejection on the grounds of being incomplete.

**ADDITIONAL INFORMATION**

**SECURITY**

- 20.1 Due to the nature of this contract in the services that will be terminated, they may be in need in certain instances for the contractor to take additional precaution measures to safeguard the staff and the property.

**ETHICAL CONDUCT**

- 21.1 It is expected of a contractor to conduct themselves in an ethical manner in the execution of this contract. Should anything to be contrary will be deemed in a serious right and the necessary action will be implemented, including but not limited to termination of the contract.

**NOTICE**

- 22.1 Any notice or communication required or permitted to be given in terms of this agreement shall be valid and effective only if in writing and may be given in one or more of the following manners: -
- 22.1.1 Sent by prepaid registered post (by airmail if appropriate) in an envelope correctly addressed to it at an address chosen as its *domicilium citandi et executandi* to which post it is delivered, in which event such notice shall be deemed to have been received on the 7<sup>th</sup> (seventh) business day after posting (unless the contrary is proved); or
- 22.1.2 Delivered by hand to a responsible person during ordinary business hours at the physical address chosen as its *domicilium citandi et executandi*, in which event such notice shall be deemed to have been received on the day of delivery; or
- 22.1.3 Sent by telefax to its chosen telefax number stipulated in 16.1, in which event such notice shall be deemed to have been received on the date of dispatch (unless the contrary is proved).
- 20.2 Notwithstanding anything to the contrary herein contained a written notice or communication actually received by a party shall be adequate written notice or communication to it notwithstanding that it was not sent to or delivered at its *domicilium citandi et executandi*.

**1. Definitions** 1. The following terms shall be interpreted as indicated:

1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.

1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.

1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.

1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.

1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.

1.7 "Day" means calendar day.

1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.

1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.

1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.

1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.

1.14 "GCC" means the General Conditions of Contract.

1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or

materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.

1.17 "Local content" means that portion of the bidding price, which is not included in the imported content provided that local manufacture does take place.

1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.

1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.

1.20 "Project site," where applicable, means the place indicated in bidding documents.

1.21 "Purchaser" means the organization purchasing the goods.

1.22 "Republic" means the Republic of South Africa.

1.23 "SCC" means the Special Conditions of Contract.

1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.

1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.

1.26 "Tort" means Delict

1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.

1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

## 2. Application

2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.

2.2 Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.

2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

**3. General** 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.

3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

**4. Standards** 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

### **5. Use of contract documents and information inspection**

5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.

5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.

5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser

5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

### **6. Patent Rights**

6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

6.2 When a supplier develops documentation / projects for the municipal owned entity (MOE), the MOE shall retain ownership of any written opinion, advice, presentation or other deliverable that the supplier produces for the MOE in its tangible form on payment of all fees due, owing and payable to the supplier. The ownership of the intellectual property rights in the services, products of the services and the methodology and technology used to perform the services and all its working papers shall be retained by the supplier.

### **7. Performance security**

7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.

7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:

- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
- (b) a cashier's or certified cheque.

7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.

### **8. Inspections, tests and analyses**

8.1 All pre-bidding testing will be for the account of the bidder.

8.2 If it is a bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, tests and analyses, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the

purchaser or organization acting on behalf of the purchaser.

8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.

8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.

8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.

8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

### 9. Packing

9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.

### 10. Delivery and documents

10.1 Delivery of the goods and arrangements for shipping and clearance obligations, shall be made by the supplier in accordance with the terms specified in the contract.

### 11. Insurance

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

### 12. Transportation

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.

### 13. Incidental Services

13.1 The supplier may be required to provide any or all of the following services, including additional services, if any:

(a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;

(b) furnishing of tools required for assembly and/or maintenance of the supplied goods;

- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

#### **14. Spare parts**

14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and;
- (b) in the event of termination of production of the spare parts:
  - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
  - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

#### **15. Warranty**

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

**16. Payment** 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.

16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.

16.3 Payment shall be made within 30 days of receipt of the supplier statement, provided the statement submitted is correct and submitted to Johannesburg Water before the end of the month. The invoice for which payment is required must be correct, must be reflected on the statement referred to above and also be submitted by no later than the end of the month.

16.4 Payment will be made in Rands unless otherwise stipulated.

### 17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

### 18. Variation in contractual hours

18.1 In the event that work to be performed in terms of this contract be completed in less than the envisaged time, or in the event that the duration of such work exceeds the envisaged time pursuant to the approval by JW of an exception report referred to in clause 8 of the Scope of Work, the rate per hour payable to the contractor shall remain the same.

**19. Assignment** 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

### 20. Subcontracts

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

### 21. Delays in the supplier's performance

21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.

21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.

21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.

21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase goods of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

### 22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

### 23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the supplier fails to perform any other obligation(s) under the contract; or

(c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner, as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.

23.5 . Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 . If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters.

When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of

restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website

### 24. Antidumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to goods or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

### 25. Force Majeure

25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

### 26. Termination for insolvency

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.

### 27. Settlement of Disputes

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

27.4 Notwithstanding any reference to mediation and/or court proceedings herein,

(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and

(b) the purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

### 28. Limitation of Liability

28.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;

(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of

profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

### 29. Governing language

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

### 30. Applicable law

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

**31. Notices** 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.

31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

### 32. Taxes and duties

32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.

32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.

32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.

32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

### 33. Transfer of contracts

33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser

### 34. Amendment of contracts

34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

### 35. Prohibition of restrictive practices

35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.

35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in section 59 of the Competition Act No 89 Of 1998.

35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
